

Sequential Timeline for the Consolidation of Alabama Southern Community College, Faulkner State Community College, and Jefferson Davis Community College

The revised projected timeline for the consolidation process spans from November 2015 through December 2017:

- ✓ November 12, 2015: Discussion Item regarding Consolidation of colleges by Alabama Community College System Board of Trustees (Board of Trustees).
- ✓ December 10, 2015: Through a Resolution, the Board of Trustees approved initiating the planning process for consolidation of four colleges. Dr. Gary L. Branch designated as Lead President of the consolidation process and Faulkner State designated as the lead institution.
- ✓ December 11, 2015: Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) notified of intent to consolidate.
- ✓ January 15, 2016: Statement of Intent to Consolidate three colleges submitted to the Alabama Commission on Higher Education (ACHE).
- ✓ January 15, 2016: Request for Administrative Consolidation submitted to ACHE.
- ✓ January 21, 2016: U.S. Department of Education notified of proposed consolidation.
- ✓ February 1, 2016: Initial meeting of Consolidation Committees.
- ✓ February 8, 2016: Request for Administrative Consolidation submitted to the Board of Trustees.
- ✓ March 8, 2016: Board of Trustees approved the Statement of Intent to Consolidate.
- ✓ March 11, 2016: ACHE approved Statement of Intent to Consolidate.
- ✓ May 2, 2016: Supplemental addendum worksheet to administrative consolidation request submitted to ACHE.
- ✓ July 20, 2016: Final revised Supplemental addendum worksheet to administrative consolidation request submitted to ACHE.
- ✓ July 29, 2016: College Name, Mission Statement, Campuses, Instructional Sites, and Service Area submitted to the Board of Trustees for approval.

Revised Timeline
September 2016

- ✓ August 10, 2016: Board of Trustees approves the College Name, Mission Statement and Designation of Locations.
- ✓ August 10, 2016: Request for Administrative and Programmatic Consolidation submitted to the Board of Trustees.
- ✓ September 1, 2016: Submit Prospectus to SACSCOC.
- September 9, 2016: ACHE decision on the Administrative and Programmatic Consolidation Request.
- September 14, 2016: Board of Trustees decision on the Administrative and Programmatic Consolidation Request.
- September 15, 2016: Submit Addendum to Prospectus.
- November 9, 2016: Submit Request to Implement Consolidation to the Board of Trustees.
- December 3-6, 2016: SACSCOC Board of Trustees decision on the Prospectus.
- December 14, 2016: Board of Trustees final approval of the Consolidation.
- December 15, 2016: Notify U.S. Department of Education (USDOE) of SACSCOC Accreditation and Board approval of the newly consolidated institution.
- January 2017: Implementation of Administrative and Programmatic Consolidation for Coastal Alabama Community College.
- April 2017: On-site Substantive Change Committee visit.
- December 2017: SACSCOC Board of Trustees decision on continuing accreditation of the new College.
